# Cass County Seals Short Course Season

## 2009-2010 Fees and Parental Participation

The short course season will run from September 2009 through March 2010. Information regarding fees and parental involvement is given below. No child will be turned away due to financial reasons. **A minimum of \$50 per child must be paid PRIOR to your child(ren) participating in ANY CCS Short Course Season swim practice.** Half of the remaining balance is due no later than October 5<sup>th</sup>, 2009. The remaining balance is due no later than November 1<sup>st</sup>, 2009.

### SWIM MEET INVOLVEMENT

Because we are a non-profit swim team, we must host a swim meet each fall to raise money. This year's meet will be held on Oct 24-25, 2009. It is necessary that EVERY family be involved in this in some way by providing one person to work during one four-hour session of the swim meet. (This person can be a relative or family friend. Two people may work two hours each.) You may work more if you wish! Also pay the following fees per child.
